MOTION FOR EXTENSION OF TIME


BellSouth Telecommunications, Inc., d/b/a AT&T Kentucky (“AT&T Kentucky”), and AT&T Communications of the South Central States, LLC (“AT&T Communications”) (collectively, “AT&T”), by counsel, hereby move the Public Service Commission of the Commonwealth of Kentucky (the “Commission”) for an extension of time to file its Second Requests for Information to Windstream Kentucky West Inc., Windstream Kentucky East, Inc. – Lexington, and Windstream Kentucky East, Inc. – London (“Windstream”).

The Commission’s Order dated March 11, 2009, set out the procedural schedule in this case. Initial Data Requests were due March 30, 2009, Responses to the Initial Data Requests were due April 24, 2009, and the Second Set of Data Requests is due today, May 8, 2009. AT&T served its Initial Data Requests on Windstream on April 24,

2009, as required by the Commission's Order, but to date Windstream has not responded to AT&T's Initial Data Requests. For that reason, AT&T requests an extension of time to 30 days after Windstream's files its Responses to AT&T's Initial Data Requests in which to file its Second Set of Data Requests to Windstream.

For the foregoing reason, AT&T respectfully requests that the Kentucky Public Service Commission grant its motion for an extension of time to file its Second Set of Data Requests to Windstream.


