O R D E R

On May 21, 2008, the Commission consolidated Case No. 2008-00147¹ with this case, finding that both cases involved the same jurisdictional utility and the same contractor crew and were based on actions that occurred only a day apart on the same distribution line construction project. On September 29, 2008, the Commission entered its final Order in Case No. 2008-00069, adopting a comprehensive settlement agreement which resolved all of the violations cited in the consolidated cases.

Consequently, the Commission, on its own motion, finds that Case No. 2008-00147 should be closed and removed from the Commission's active docket.

IT IS THEREFORE ORDERED that:

1. Case No. 2008-00147 is closed and is removed from the Commission's docket.


