COMMISSION STAFF'S SECOND  
DATA REQUEST TO CITY OF DANVILLE

The city of Danville ("Danville"), pursuant to 807 KAR 5:001, is to file with the Commission the original and 10 copies of the following information, with a copy to all parties of record. The information requested herein is due within seven days of the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Danville shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which Danville fails or refuses to furnish all or part of the requested information, Danville shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Has Danville paid Parksville Water District ("Parksville") any part of the \$38,171.18 found under the terms of the Proposed Settlement Agreement filed with the Commission on June 1, 2009? If so, list the amounts of any such payments and the date each payment was made.


2. If no such payment has been made to date, does Danville intend to pay Parksville the full amount of \$38,171.18? If so, when and under what conditions will said payment be made?

3. Has Danville paid Garrard County Water Association, Inc. ("Garrard") any part of the \$18,270.44 found under the terms of the Proposed Settlement Agreement filed with the Commission on June 4, 2009? If so, list the amounts of any such payments and the date each payment was made.

4. If no such payment has been made to date, does Danville intend to pay Garrard the full amount of \$18,270.44? If so, when and under what conditions will said payment be made?

5. Has Danville paid Lake Village Water Association, Inc. ("Lake Village") any part of the \$28,845.14 found under the terms of the Proposed Settlement Agreement filed with the Commission on June 1, 2009? If so, list the amounts of any such payments and the date each payment was made.

6. If no such payment has been made to date, does Danville intend to pay Lake Village the full amount of \$28,845.14? If so, when and under what conditions will said payment be made?
