2. The rates and charges set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

The following rates and charges are prescribed for the customers in the area served by Wood Creek Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

Nonrecurring Charges

Additional Trip charge	\$40.00
Deposit - Residential	\$60.00
Deposit - Commercial	\$100.00
Reconnection / Service charge	\$40.00
Reconnection charge (after hours)	\$80.00
Returned Check Charge	\$25.00

A charge of \$40.00 will be charged to the London Utility Commission for reconnection of water service for its sewer customers.
