RATE SCHEDULE--CLASSIFICATION OF SERVICE

*MONTHLY CONSTRUCTION CONTRIBUTION: In accordance with the Order of the Public Service Commission in Case No. 95-409, a construction contribution charge of \$12.00 per month per meter shall be paid by all customers located on Rockbridge Road and Davis-Morris Road in Shelby County. This shall be paid only by customers whose service line is directly connected to the extension installed under the authority of that Order, and not to extensions or laterals therefrom. This payment shall begin with each customer's first bill and shall continue until the construction contribution loan has been fully paid, or until April 16, 2011, whichever first occurs.
