MOTION TO REASSIGN HEARING



FOR EXTENSION OF TIME TO FILE TESTIMONY

Comes South Kentucky Rural Electric Cooperative Corporation, (“South Kentucky”) by counsel, and moves the Commission to reassign the public hearing scheduled for June 9, 2009 for the reason that the undersigned attorney for South Kentucky has a scheduling conflict and cannot be present on that day. Any of the three following dates would be available to South Kentucky and apparently also available to the Commission: June 25, 2009, July 7, 2009 and July 8, 2009. Accordingly, the Commission is requested to reschedule the public hearing for one of those three dates if possible.

Additionally, South Kentucky requests and extension of time to file testimony. The Commission’s order of April 20, 2009 indicates that testimony shall be filed no later than April 28, 2009. South Kentucky requests an extension up to and including May 22, 2009 to file testimony. There is an abundance of information to gather and present and South Kentucky does not believe that it will be able to adequately present the issues to the Commission by means of testimony by the April 28, 2009 deadline. Additionally, South Kentucky’s regular monthly

board meeting in May will occur May 14, 2009 and it is likely that the matters to be presented to the Commission will need to be discussed at the board meeting.


