O R D E R

On September 23, 2008, Letcher County Judge/Executive Jim Ward applied to the Commission to fill two vacancies on Letcher County Water District's ("Letcher District") Board of Commissioners, which became vacant due to the expiration of current members' terms on June 1, 2008.¹ Judge Ward and Letcher County Fiscal Court have recommended that Phillip Back and Billy Stamper be appointed to fill the vacant positions.² On the same day, Jim Murtaugh, Letcher District's Operations Manager and Interim Executive Director,³ requested that the Commission appoint Seth Long and Donald Profitt to fill the vacant positions.

Pursuant to KRS 74.020(1)(a), a county judge/executive appoints water district commissioners with the approval of the county's fiscal court. KRS 74.020(4), however, provides that the Commission shall fill a vacancy on the board of commissioners "if,

within ninety (90) days following the expiration of the term, the vacancy has not been filled by the appropriate county judge/executive with approval of the fiscal court.”

As the term of each Letcher District commissioner expired on June 30, 2008,⁴ and the positions have been vacant for more than 90 days, the Commission has the statutory duty and the exclusive authority to fill the vacant positions.⁵ While a county judge/executive and a county fiscal court may reach agreement on the vacant position, they lack authority to fill the vacancy once it has remained unfilled for more than 90 days. Any action on their part to appoint and approve a candidate at that time has limited legal effect and constitutes only a recommendation to the Commission.

Based upon the above, the Commission finds that a case should be established to consider the application and to select the appropriate persons to fill the present vacancies on Letcher District’s Board of Commissioners.

Notwithstanding the provisions of KRS 67.710, a vacancy resulting from the expiration of a term shall be filled by the Public Service Commission if, within ninety (90) days following the expiration of the term, the vacancy has not been filled by the appropriate county judge/executive with approval of the fiscal court.

IT IS THEREFORE ORDERED that:

1. This case is established to fill the two vacancies on Letcher District's Board of Commissioners.

2. Members of Letcher County Fiscal Court,⁶ Judge Ward, and Letcher District are made parties to this case.

3. Any party filing documents with the Commission shall serve a copy of those documents upon all other parties.

4. Service of any document or pleading shall be made in accordance with Administrative Regulation 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5.02.

5. Within 20 days of this Order, Judge Ward shall file with the Commission the original and 6 copies of the information listed in Appendix A, with a copy to all parties of record.

6. Within 20 days of this Order, Letcher District shall file with the Commission the original and 6 copies of the information listed in Appendix B, with a copy to all parties of record.

7. a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or

person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. Any party shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any requests to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.


e. Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request.

8. Any party who wishes to nominate a person to fill the vacancy shall submit its nomination to the Commission in writing within 20 days of the date of this Order.
