## NOTICE

The Purchase Public Service Corporation, doing business as Great Oaks Subdivision, has filed an application with the Public Service Commission to increase its rates for sewer service. These rates apply to those customers who have sewer service only. The proposed effective date of the change is January 1, 2009.

Copies of the application may be obtained at no charge from the utility office at Great Oaks Subdivision, Lebanon Church Rd., Paducah, KY. Upon request from an intervenor, the utility shall furnish to the intervenor a copy of the application and supporting documents.
