RIGHT-OF-WAY-EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, _____ and _____ GRANTOR(s) for a good and valuable consideration, the receipt to which is hereby acknowledged, do hereby grant unto Big Sandy Rural Electric Cooperative Corporation, Paintsville, Ky., GRANTEE and to its successors or assigns the right of ingress and egress upon the lands of the GRANTOR(s), with the right to construct, reconstruct, operate, maintain, relocate, inspect, repair and remove on the below-described lands an electric power line or system and tele-communication line or system with all necessary poles and equipment, to cut and trim trees and shrubbery that may interfere with or threaten to endanger the operation, maintenance and removal of said lines or systems and to license, permit or otherwise agree to the joint use of occupancy of the poles, line or system by any other person, association or corporation, for electrification or tele-communication purposes.

The easement shall be 35 feet in width and shall be perpetual over, across and through the land of the GRANTOR(s) as described herein.

Described location:

Being the same land described in Deed Book Number _____, Page Number _____. Recorded in _____ (County) Court Clerk's office. Which description is incorporated herein by reference, together with RIGHT of ingress and egress over the adjacent lands of the GRANTOR, his successors and assigns, for the purposes of this easement to serve this member as well as other members of the Co-op.

The consideration herein above recited shall constitute payment in full for any damages to the land of the GRANTOR, his successors and assigns, by reason of the installation, operation, maintenance and removal of the structures or improvements referred to herein. The GRANTEE covenants to maintain the easement in good repair so that no unreasonable damage will result from its use to the adjacent land of the GRANTOR, his successors and assigns.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTEE, its successors and assigns.
