To the COMMISSION:

The PEAKS MILL WATER DISTRICT respectfully requests that the COMMISSION allow us to make an adjustment in our rates in accordance with 807 KAR 5:067 Purchased Water Adjustment clause.

The District has been told by its supplier, Frankfort Electric and Water Plant Board that a \$0.0465 increase will take effect on November 30, 2008 and a \$0.283 increase on December 8, 2008. The Company purchased 86,126,100 gallons from Frankfort between November 2007 and October 2008. The result of these increases is an increase to our rates of \$0.43 per 1,000 gallons. We propose to raise each gallonage block that amount.
