I have deep concerns about the requested rate increase of 50.8% by Utilities Inc. The decision to approve this request will affect my family in negative ways. I am a stay-at-home-mother of 3 children. We live in a 1560 square foot home and our water bill usually runs between \$150-200/month. It is a hardship already, I cannot imagine how much it will hurt us in the future. My husband has a good paying job, but if the rate increase is approved, I honestly don't know how we will manage. Like I already mentioned, we have 3 small children to provide for. We don't have a garden or use a HUGE amount of water. Of course, we have 5 showers taken daily and the laundry that goes along with that. We have lived in this house for (almost) 9 years. When we

first moved here, our water bill was running about \$30/month. I have noticed that the rates have already gotten higher, MUCH higher. Please don't approve this request. If we have difficulty with the amounts we already pay, I cannot imagine how the elderly that are on a fixed income are making it, along with less fortunate families that are on state assistance.

I request that you hold a meeting in the city of Clinton so that the citizens can attend and voice their opposition to you directly.
