O R D E R

Water Service Corporation of Kentucky ("Water Service") has applied for approval to adjust its rates for water service. On April 3, 2009, the Commission suspended the operation of the proposed rates for a period of five months and established a schedule for review of the proposed rates. The procedural schedule required Intervenor testimony to be filed no later than June 26, 2009. The Attorney General is the only Intervenor in this case, and he has not filed any testimony. The future deadlines established by the Order of April 3, 2009, all relate to discovery of the Attorney General's testimony and rebuttal to that testimony.

The Commission, therefore, finds good cause to amend the procedural schedule.

IT IS HEREBY ORDERED that:


1. The procedural schedule set forth in Appendix A to this Order shall be followed.
2. All provisions of the Commission's Order of April 3, 2009, other than the procedural schedule shall remain in effect.

3. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
