

This letter is written to clear up the inconsistencies contained in filings made by or on behalf of Big Rivers Electric Corporation in this matter that have created confusion regarding the amount of the Annual Facility Fee Big Rivers anticipates for the letter of credit facility. The correct information is that the Annual Facility Fee, if the letter of credit facility were entered into on this date, would be 100 basis points times the amount of the letter of credit facility, which is \$15,000,000, for a total amount of \$150,000. We apologize for the confusion created by the inconsistent information provided in our prior submittals.
