1. Citipower is willing to modify its Quarterly Report of Gas Cost Recovery Rate Calculation, filed February 23, 2009, based upon comments from the staff of the Public Service Commission relating to a three month price average based upon the following calculation:

Taking the "NYMEX Natural Gas 12-Month Strip" for March 26, 2009 multiplied by 1.2 (for the BTU factor); then multiplying that number by two (for 2 months) and adding it to the existing contract gas cost per Mcf (\$11.38 - April); and then dividing that sum by 3 for an average price for the quarter ending June 30, 2009.

Calculation example:

$$\begin{array}{r} [(4.63 \times 1.2) \times 2] \quad = \quad 11.112 \\ [(11.38 \times 1.2) \quad ] \quad = \quad 13.656 \\ \hline \quad \quad \quad \quad \quad \quad \quad 24.768 \end{array} \quad 24.768 / 3 = \$8.256$$




