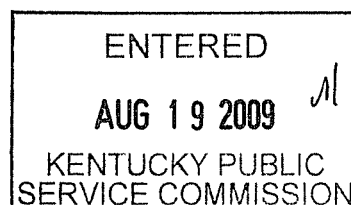
The Commission, based on its own motion and being otherwise sufficiently advised, HEREBY ORDERS that:

1. A public hearing on this matter will commence at 10:00 a.m., Eastern Daylight Time, on September 16, 2009 at the Commission's offices
2. Columbia shall publish notice of the public hearing in newspapers of general circulation in the areas that will be affected by the outcome of this proceeding. Such notice shall be published at least seven days prior to the date of the public hearing.
3. The issue of filing post-hearing briefs will be addressed at the public hearing.
