RE: Informal Conference of September 8, 2008

On September 8, 2008, an informal conference ("IC") was held in this case for the purpose of discussing issues related to scheduling witnesses for cross-examination at the hearing in this proceeding to be held on September 16 – 18, 2009. In addition to the intended purpose of the meeting (scheduling of witnesses), Commission Staff was informed that Columbia Gas and the Attorney General had been discussing possible settlement of the case. Commission Staff was also informed that the intervenors other than the Attorney General had just been made aware of said discussions prior to the beginning of the IC. Columbia Gas and the Attorney General indicated that they intended to bring the other parties "up to speed" regarding the extent of the discussions. They further indicated that they expected they would be able to inform Commission Staff within two to three days of whether or not the parties had agreed on a settlement of the issues in the case.

While a number of the parties participated in the IC telephonically, several of the parties' representatives attended in person. An attendance list, including the names of those participating by telephone, is attached to this memorandum, which Commission Staff indicated would be prepared and filed in the record of this case.
