Green River Valley Water District ("Green River"), acting by and through its Board of Commissioners, respectfully tenders this application, pursuant to 807 KAR 5:001, and Chapter 278.020 (1) and all other applicable laws and regulations, requests that the Public Service Commission enter an Order for (1) approval of a waterworks improvement project and (2) approval of financing from the Kentucky Rural Water Finance Corporation.

Green River is a non-profit water district organized under KRS Chapter 74 and has no separate articles of incorporation or by-laws. Green River's mailing address is PO Box 399, Cave City, Kentucky 42127.

Green River is engaged in the distribution and sale of water. It currently provides service to approximately 6,683 retail customers and 7 wholesale customers.

As required by 807 KAR 5:001, Section 8(2), Green River is filing an original and ten copies of this application with the Commission and one copy to
