Comes the Horse Cave Water Commission ("Horse Cave"), by  
Counsel, and states as follows:

1. Horse Cave sought, and was granted, full intervention rights in this case by an Order of the Kentucky Public Service Commission ("Commission").
2. Horse Cave is the largest wholesale water customer of the Green River Valley Water District ("Green River District").

3. Since the filing of Green River District's Application for a Certificate of Public Convenience and Necessity ("Application") to construct the proposed water system improvement project ("Project"), Horse Cave has evaluated the merits of, and need for, the Project.

4. Following this evaluation, Horse Cave has determined that construction of the Project is necessary, in the public interest, and will not result in a wasteful duplication of facilities.


5. Construction of the Project will enable the Green River District to adequately supply the water demands of Horse Cave under average conditions and during times of peak demand.

6. Therefore, Horse Cave supports the Project, withdraws any prior objections to the Project, and urges the Commission to expedite the approval of the Project and issuance of the Certificate of Public Convenience and Necessity so that the construction contracts can be awarded before the expiration of the favorable construction bids.

WHEREFORE, for the foregoing reasons, the Horse Cave Water Commission withdraws any prior objections to the Project and respectfully requests the Commission to expedite the approval of the Project and issuance of the Certificate of Public Convenience and Necessity.
