O R D E R

On May 20, 2009, Allen County Water District ("Allen District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Allen District purchases water from the Glasgow Water and Sewer Commission ("Glasgow") and from City of Scottsville ("Scottsville").

2. Glasgow notified Allen District that it will increase its wholesale water rate effective July 1, 2009 and that Glasgow's wholesale water rate to Allen District will increase from \$1.75 per 1,000 gallons to \$1.95 per 1,000 gallons. Allen District proposes to increase the water rates to its customers effective July 1, 2009.

3. During the 12 months ending March 31, 2009, Allen District purchased a total of 347,791,400 gallons of water from Glasgow and purchased a total of 8,943,800 gallons of water from Scottsville and sold a total of 295,078,700 gallons of water. The increase in the cost of purchased water is \$69,558.28, resulting in a purchased water adjustment of \$0.24 per 1,000 gallons.

4. A purchased water adjustment of \$0.24 per 1,000 gallons is fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

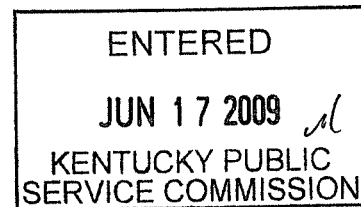
1. Allen District's proposed rates are approved.

2. The purchased water adjustment increase of \$0.24 per 1,000 gallons as calculated in the attached Appendix A is approved.


3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after July 1, 2009.

4. Within 20 days of the date of this Order, Allen District shall file with the Commission revised tariff sheets containing the approved rates.
