**MOTION OF LOUISVILLE GAS AND ELECTRIC COMPANY
TO MODIFY PROCEDURAL SCHEDULE**

Louisville Gas and Electric Company (“LG&E”) hereby moves the Public Service Commission (“Commission”) to modify the procedural schedule in this proceeding in the manner set out below to afford LG&E the opportunity to file rebuttal testimony to any testimony that intervenor, Kentucky Industrial Utility Customers, Inc. (“KIUC”), may file in this proceeding. Allowing time for rebuttal testimony will require rescheduling the hearing date in this proceeding, currently scheduled for November 3, 2009. The undersigned is authorized to represent that KIUC has no objection to the proposed modification to the procedural schedule. LG&E and KIUC also believe an informal conference on September 30 or October 1, 2009 would allow the parties to discuss the issues and possibly resolve them by settlement. Therefore, LG&E respectfully moves the Commission to modify the procedural schedule of this proceeding as follows (regular type indicates dates already in the procedural schedule that LG&E does not propose to change; italic type indicates new or changed dates):

All supplemental requests for information to
LG&E shall be filed no later than 09/11/09

LG&E shall file responses to supplemental
requests for information no later than 09/22/09

Informal Conference *09/30/09 or 10/01/09*

Intervenor testimony, if any, in verified prepared form, shall be filed no later than	10/06/09
All requests for information to Intervenors shall be filed no later than	10/15/09
Intervenors shall file responses to requests for information no later than	10/23/09
<i>LG&E shall file rebuttal testimony no later than</i>	<i>10/30/09</i>
<i>Public hearing to be held in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of cross-examination of witnesses of LG&E and Intervenors</i>	<i>11/10/09</i>

WHEREFORE, LG&E respectfully moves the Commission to enter an order modifying the procedural schedule in this proceeding as set out above (1) to afford LG&E the opportunity to file rebuttal testimony in response to whatever testimony KIUC files in this proceeding and (2) to schedule an informal conference to facilitate settlement discussions.
