
Pursuant to the Rules Governing Tariffs (effective August 4, 1984), I hereby certify that I am Lonnie E. Bellar, Vice President, State Regulation and Rates for Louisville Gas and Electric Company (“LG&E” or “Company”), a utility furnishing retail electric service within the Commonwealth of Kentucky which, on the 26th day of June, 2009, filed an application with the Kentucky Public Service Commission seeking an order granting LG&E a Certificate of Public Convenience and Necessity for the construction of a new landfill at the Trimble County Generating Station, and pursuant to KRS 278.183 approving an amended compliance plan for purposes of recovering the costs of new pollution control facilities through its Environmental Surcharge tariff. Notice to the public of a hearing in this matter has been completed in substantial or complete compliance with Section 8(5) of 807 KAR 5:011 as follows:

On October 26, 2009, LG&E contacted the Kentucky Press Association, an agency that acts on behalf of newspapers of general circulation throughout the Commonwealth of Kentucky in which customers affected reside, for publication in such newspapers one time before November 3, 2009, pursuant to 807 KAR 5:011, Section 8(5), a notice of hearing on November 3, 2009 in this case. 
