O R D E R

On June 12, 2009, Madison County Utilities District (“Madison County”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Madison County purchases water from Richmond Utilities (“Richmond”).
2. Richmond notified Madison County that, effective with its July 1, 2009 billing, Richmond's wholesale water rate to Madison County would increase from \$2.08 per 100 cubic feet to \$2.14 per 100 cubic feet. Madison County proposes to increase the water rates to its customers effective July 1, 2009.
3. During the 12 months ending April 30, 2009, Madison County purchased a total of 91,043,100 cubic feet of water and sold 83,191,449 cubic feet. The increase in the cost of purchased water is \$54,625.86, resulting in a purchased water adjustment of \$0.07 per 100 cubic feet.

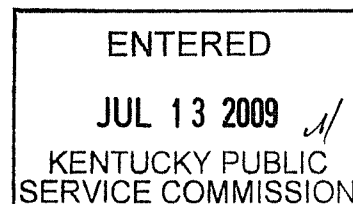
4. Madison County incorrectly applied the purchased water adjustment of \$0.07 per 100 cubic feet to its current rates. The rates proposed by Madison County should be denied.

5. The purchased water adjustment of \$0.07 per 100 cubic feet is fair, just, and reasonable and should be approved.


IT IS HEREBY ORDERED that:

1. The rates proposed by Madison County are denied.
2. The purchased water adjustment of \$0.07 per 100 cubic feet, as calculated in Appendix A, is approved.
3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on or after July 1, 2009.
4. Within 30 days of the date of this Order, Madison County shall file new tariff sheets showing the rates approved herein.
