


NOTICE OF APPEARANCE PRO HAC VICE



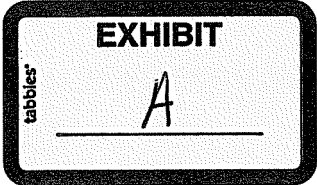

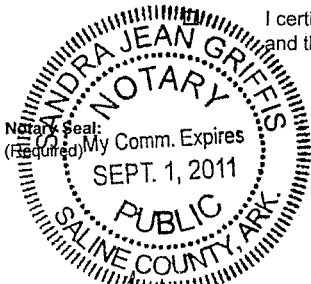
