





REQUEST 1**

RESPONSIBLE PARTY: Ann F. Wood

Request 1. Refer to the backup documentation filed with the fuel adjustment clause information for the November 2008 expense month. What does the approximate \$3,000 in green tags represent?

Response 1. EKPC generates Renewable Energy Credits ("REC") through the operation of its landfill gas generating units. The REC's are based on one REC for every one megawatt hour of generation. The REC's are synonymous with green tags. EKPC has not purchased any REC's to date. The \$3,600 charge included in the November 2008 fuel adjustment clause expense relates to brokerage fees incurred for the sale of 2007 REC's. EKPC credits the net proceeds (gross proceeds less brokerage fees) of REC sales to methane fuel expense to give the member systems the benefit of lower fuel costs. Often, invoices for brokerage fees are received in months following the receipt of the proceeds.

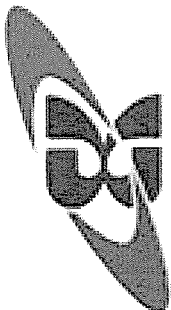
