On March 3, 2010, an informal conference was held in this case for the purpose of discussing issues relating to the Joint Settlement Stipulation and Recommendation ("Settlement") between Clark Energy Cooperative, Inc. ("Clark") and the Office of the Attorney General filed with the Commission on February 25, 2010. A list of attendees is attached to this memorandum.

Staff asked a few clarifying questions related to items in the Settlement that required correcting or updating. Staff also requested that Clark provide an amendment to the Settlement to specify the depreciation rates being proposed in the Settlement. Clark agreed to provide corrected copies and an amendment to the Settlement. The proposed effective date of April 1, 2010 for the rates contained in the Settlement was discussed in connection with Clark's billing cycles and the Commission's ability to issue an order in a timely manner, depending on (1) the hearing date established by the Commission and (2) whether the Settlement receives Commission approval.

There being no other questions, the meeting was adjourned.
