IT IS HEREBY ORDERED that:

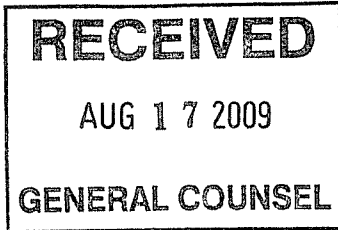
1. The motion of KIUC to intervene is granted.


