

Comes now the applicant, the Louisville and Jefferson County Metropolitan Sewer District ("MSD"), by and through counsel and gives notice that it would like to withdraw its application to approve the acquisition of the Shadowwood wastewater treatment plant, Case No. 2009-00336. MSD is requesting to withdraw its application so that it can resubmit a supplemental application to clarify certain facts relating the acquisition and to submit additional information concerning financial expenditures pertaining to improvements made by MSD to Shadowwood. MSD will also be tendering information relevant to the overriding federal consent decree between the United States Environmental Protection Agency and MSD concerning MSD's operations and compliance with the Clean Water Act, 33 U.S.C. §1251 et seq. MSD will file the new, supplemental application on or before, December 11, 2009.
