1a. The task the contractor performs for the \$200.00 fee includes providing a backhoe, trencher, and an operator. Whether it takes 2 hours or 2 days to set a meter the fee is a flat rate of \$200.00.


1b. The task that the employee performs in connection with the setting of a meter includes making sure the meter is set at the proper location on the property, finding the main for the tap, inspecting all locations before the lines are covered up after the tap has been made and working with the operator to complete the work.

1c. It is necessary to have an employee with our contractor at all times because East Daviess County Water Association is responsible for the overall safety and quality of the water we serve to our customers as well as the responsibility of all connections to our water mains. Having an employee work with the contractor also helps with problems that may come up in the future such as leaks or line locations.

1d. The site cleanup is started at the time of the meter installation. However, the dirt has to be given time to settle before it can be properly worked up, grass sown and straw spread. This requires another trip back to the meter installation site.

This work is done by the same employee who was in attendance with the contractor when the installation is made.

2a. Employees are paid a minimum of 2.5 overtime hours when called out after regular working hours.

2b. The wage rate per hour for overtime work by the serviceman is \$26.97.

Previously I had mistakenly had some benefits added in the overtime amount. The amount in #3(b) should have been listed as \$67.43 for 2.5 hours overtime.
