Since we can't talk until 4:00 this afternoon, I wanted to make clear our view regarding the PSC proceeding. Doug, when we spoke yesterday you had mentioned that LG&E/KU will ask the PSC to reconsider their order regarding the establishment of a surcharge and that if they don't grant this motion you will likely pull the case.

In our discussion up to this point, Invenergy has tried to be as flexible as possible including our willingness to delay the condition precedent for transmission approval. From our side, a strategy that requires a surcharge as the only way to get rate recovery does not appear very flexible or very likely to succeed. We just would like to make sure that we are both using reasonable and diligent efforts to get the approvals needed.

We look forward to discussing with you further today. We want to continue to work with LG&E/KU to help find a solution that has a likely successful outcome.
