SUBJECT: Informal Conference
Case No. 2009-00451 - Application of Jackson Purchase Energy Corporation to Amend Tariffs

At the request of Jackson Purchase Energy Corporation ("Jackson Purchase"), a telephonic informal conference ("IC") was held on July 28, 2010. A copy of the conference attendance list is attached. The purpose of the conference was to discuss Jackson Purchase's proposal to amend several of its tariffs.

Jackson Purchase addressed questions asked by Commission Staff ("Staff") to clarify certain aspects of the proposed tariff changes. Jackson Purchase also identified other utilities with which its proposed tariffs can be compared. At Staff's request, Jackson Purchase agreed to file a cost justification calculation for the new 150 watt Metal lighting fixture proposed to be added to Schedule OL – Outdoor Lighting. The requested calculation will be filed no later than the week of August 2, 2010.

The manner in which Jackson Purchase will number its tariff sheets, if some or all of the proposed tariff changes are approved by the Commission, was also discussed.

The IC was then adjourned.
