

Public Petition to Oppose a 34.95 Percent Increase In Electric Bills

Category: Request to Intervene Case Number 2009-00459 For Citizens of Floyd County

Region: Southeastern Kentucky

Target: The Executive Director of Public Service Commission of Kentucky

Background (Preamble)

Please Support the Citizens of Floyd County By Not Approving the 34.95 Percent Requested By Kentucky Power.

Petition:

We, the undersigned, hereby petition the Public Service Commission of Kentucky to support the citizens of Floyd County by not approving the base rate, case 2009-00459, seeking \$123.6 million in relief from their customers filed by Kentucky Power on December 29, 2009.

A 34.95 percent increase on a utility bill that is already a struggle for most families would have catastrophic effects on many households. A great majority of people living in this area are on fixed incomes and would not be able to afford food, medicine, and other necessities if their income is stretched anymore.

The people of Floyd County greatly appreciate the services provided by Kentucky Power. Their employees worked long hours during the power outage the week of the Christmas Holiday. We were very grateful when the power was restored.

We, the citizens of Floyd County respectfully request that the Kentucky Public Service Commission to intervene for the people in denying Kentucky Power this rate increase. American Electric Power is one of the largest power generators and distributors in the US. Their profits last year were in the millions but their customers did not even get a cost of living raise. The people in our community just can not afford a nearly 40 percent raise in their electric bills.

Thank you for your consideration of this most important matter. Thank you for your proven leadership, consideration and support of the people in the Commonwealth of Kentucky.
