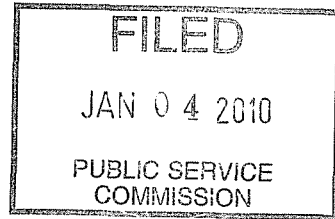

RE: Application of South Shore Water Works Co. for Increase in Non-Recurring Charges

Dear Mr. Derouen:

Pursuant to Section 8 of 807 KAR 5:006 and Section 10 of 807 KAR 5:011, South Shore Water Works Co. ("South Shore") submits this letter as an application to modify its tariff on file with the Commission to increase certain non-recurring charges. A complete list of these non-recurring charges is included in the enclosed tariff sheet and the supporting documentation. A copy of South Shore's proposed tariff sheet is enclosed as Appendix 1. In support of its application, and in compliance with Section 10 of 807 KAR 5:011, South Shore states as follows:

- Cost justification forms are included with the enclosed information for each charge proposed by South Shore and these forms provide a full description of the equipment or service being provided by South Shore. The proposed charges will cover South Shore incremental costs and make a reasonable contribution to overhead. The cost justification forms are enclosed as Appendix 2.
- A copy of the public notice that South Shore will publish once a week for three consecutive weeks in a prominent manner in a newspaper of general circulation in its service area is enclosed. This notice appeared in the Greenup County News-Times on December 3, 2009, prior to the filing of this Application, and will appear subsequently on December 10, 2009 and December 17, 2009. South Shore will file an affidavit of publication from the publisher upon receipt. A copy of the public notice is also posted for public viewing at South Shore's principal office at 809 Main Street, P.O. Box 485, South Shore, Kentucky 41175. South Shore proposes that the new rates for its non-recurring charges will become effective on January 15, 2010.
