O R D E R

On December 30, 2009, Union County Water District (“Union District”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Union District purchases water from the City of Morganfield (“Morganfield”).

2. Morganfield notified Union District that Morganfield’s wholesale water rate to Union District would increase from \$1.3487 per 1,000 gallons to \$1.3816 per 1,000 gallons, effective on December 31, 2009. Union District proposes to increase the water rates to its customers effective December 31, 2009.

3. During the 12 months ending October 31, 2009, Union District purchased a total of 266,566,700 gallons of water and sold 238,101,820 gallons. The increase in the cost of purchased water is \$8,770.04, resulting in a purchased water adjustment of \$0.04 per 1,000 gallons.

4. The tariff that Union District filed with its application listed an inaccurate rate for 5/8" meters at the 25,000-gallon step. Therefore, the rates proposed by Union District should be denied.

5. The purchased water adjustment of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

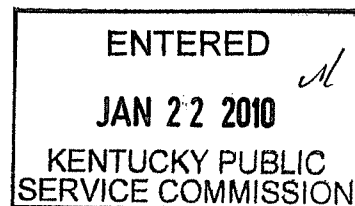
1. The proposed rates by Union District are denied.

2. The purchased water adjustment of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.


3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after December 31, 2009.

4. Within 20 days of the date of this Order, Union District shall file with the Commission revised tariff sheets showing the rates approved herein.
