

1. Kroger operates a substantial number of retail stores and distribution centers throughout the service area of Kentucky Utilities Company (“KU”) and purchases electric energy for these facilities from KU. Electric service represents a significant cost of doing business for Kroger. Kroger therefore has a special interest in this proceeding in that the Application may have a significant impact on the rates paid by Kroger to KU. 
