Comes now the Attorney General, by and through his Office of Rate Intervention, and hereby moves that the Commission redact and replace certain schedules contained in exhibits attached to the pre-filed written direct testimony of his expert witness, Mr. Michael Majoros, which was filed in both the above-styled cases.

In support of this motion, he states that said exhibits may make indirect reference to data obtained from the petitioners' data responses that were submitted under seal of confidentiality. The schedules and exhibits at issue are as follows:




