LG&E does not have a business reason to maintain ongoing files with the requested information segregated according to requested parameters. The attached

information represents LG&E's effort to extract the data according to the requested parameters within the time allowed to respond to this request for information. Please note that LG& interacts with its customers primarily through their mailing addresses. Customers' mailing addresses do not always coincide with where they take service, which may impact the attached zip code breakdown. The original attachment LG&E AG-3(b)(1) did not reflect any billing corrections or reversals that were made and resulted in a number of zip code entries that were inaccurate. The revised attachment reflects late payment charges that were billed, but not necessarily collected.
