Supplemental Data Requests to LG&E from TW Telecom


TW Telecom, LLC, pursuant to the Commission's 2/16/10 scheduling order, hereby submits the following supplemental data requests to Louisville Gas and Electric Company ("the Applicant"):

Request No. 1: Identify and quantify any differences in the costs to the Applicant between a pole attachment for a telecom provider and one for a cable system operator.

Request No. 2: Do the cost data provided in response to KCTA Requests 1-9, 18, 20-23, and 27 include costs incurred exclusively for or in connection with pole attachments for non-cable system operators? For any such costs not included, state the amounts and respective (sub)account numbers as of Oct. 31, 2009 and Dec. 31, 2009.

Request No. 3: State the revenues received from pole attachment payments by others (whether cable system operators or not) and any payments made by the Applicant to attach its facilities to others' poles for the 12 months ended Oct. 31, 2009 and for the twelve months ended Dec. 31, 2009. Identify where in filings made in this proceeding or other publicly-available filings, the Applicant has disclosed these revenues.


