Dear Mr. DeRouen:

In regard to the replacement CD furnished as part of the Attorney General's Responses. It has been brought to our attention that LGE Schedule MJM-1, Revenue Requirement Electric has an error due to our redaction. As this sheet was linked with others containing confidential information, the redaction of the confidential information "zeroed" out the cell containing the AG's recommended Consolidated Tax Adjustment. This line number 43 (cell number H-54) should have the value "\$34,851,793.00" rather than "0". With this change, the Attorney General's Total Net Adjusted Operating Income found on line number 52 of that sheet will be "\$134,815,166.00" and the Overall Revenue Deficiency/(Sufficiency) indicated on line 7, will be (\$8,344,769.00) as was indicated in the original testimony.


Additionally, the same error occurs on LGE Schedule MJM-3, Revenue Requirement Gas. The redaction of the confidential information, again, "zeroed" out the cell containing the AG's recommended Consolidated Tax Adjustment. This line number 43 (cell number H-54) should have the value "\$4,250,645.00" rather than "0". With this change, the Attorney General's Total Net Adjusted Operating Income found on line number 52 of that sheet will be "\$31,939,180.00" and the Overall Revenue Deficiency/(Sufficiency) indicated on line 7, will be (\$196,335.00) as was indicated in the original testimony.



Finally, the same error occurs on KU Schedule MJM-1, Revenue Requirement Electric. The redaction of the confidential information, again, "zeroed" out the cell containing the AG's recommended Consolidated Tax Adjustment. This line number 41 (cell number H-51) should have the value "\$56,746,683.00" rather than "0". With this change, the Attorney General's Total Net Adjusted Operating Income found on line number 51 of that sheet will be "\$227,025,769.00" and the Overall Revenue Deficiency/(Sufficiency) indicated on line 7, will be (\$12,965,563.00) as was indicated in the original testimony.
