
Dear Sir:

Thank you for the opportunity to respond to an application by Bluegrass Cellular to construct a new cell tower on highway 1157 near Bradfordsville, Ky 40009. I strongly oppose the placement of a two hundred forty foot tall tower so close to the highway as well as its profound impact on Old Liberty Cemetery, which is an active two hundred year old cemetery.

The tower's proposed site is approximately 600 feet from the cemetery. I believe it is extremely insensitive on the part of Bluegrass Cellular to propose a 24 story tower with guide wires and red flashing lights adjacent to a tranquil rural cemetery where several hundred families have loved ones buried at Old Liberty Cemetery. If Bluegrass Cellular needs another tower, I believe another less intrusive site could be found.

I will continue to oppose Bluegrass Cellular's proposal and will do all in my power to preserve the existing rural peaceful site for Old liberty Cemetery. I believe there are many families that will agree with this position.
