**MOTION FOR CLARIFICATION AND TO AMEND ORDER NUNC PRO TUNC**

Pursuant to KRS 278.400, T-Mobile Central LLC and PowerTel/Memphis, Inc. (collectively, "T-Mobile" or "Company") move the Commission to clarify its July 14, 2010 order (the "*Designation Order*") to make clear that the Commission granted T-Mobile's Petition for Designation as Eligible Telecommunications Carrier ("ETC") status within (i) the entire study areas of the rural telephone companies and (ii) the wire centers of the non-rural telephone companies identified in Exhibit A to the Petition. T-Mobile also moves the Commission to correct certain ministerial errors in the *Designation Order* while retaining the July 14, 2010 effective date for T-Mobile's ETC designation in Kentucky.

**STANDARD FOR REHEARING**

KRS 278.400 allows any party to apply for rehearing with respect to "any of the matters" determined by the Commission. Among other things, rehearing is the means for the Commission to reconsider an order in light of alleged errors and omissions.<sup>1</sup> The Commission should reconsider an order when a party identifies material evidence adduced in a proceeding that was overlooked in the Commission's order. If the Commission agrees that the existing record supports relief not fully explained by the *Designation Order*, it should amend its order.

Similarly, if the record supports additional relief that was implicitly requested in T-Mobile's Petition, a clarifying order is an opportunity to grant that relief too.

### DISCUSSION

T-Mobile's Petition requested ETC designation within the non-rural telephone company wire centers and rural telephone company study areas listed in Exhibit A. Upon review of that exhibit, the Commission apparently concluded T-Mobile was seeking redefinition of certain rural telephone company study areas. Actually, T-Mobile intended to seek designation throughout the study areas of the rural telephone companies listed in Exhibit A, whereupon redefinition would not be necessary. T-Mobile also intended to seek designation throughout the areas served by the identified wire centers of the non-rural telephone companies. T-Mobile may have confused the matter by attempting to specifically identify the wire centers in the rural telephone company study areas and using the terms "wire centers" and "exchanges" interchangeably. However, T-Mobile intended to seek designation in the entire wire centers of the non-rural telephone companies and study areas of the rural telephone companies listed in Exhibit A.

The Commission granted T-Mobile's Petition in its entirety, but, instead of describing the designated service area as the requested rural telephone company study areas, the *Designation Order* stated: "T-Mobile only requests designation as an ETC in the *wire centers* listed in the tables for Duo County Telephone Cooperative Corporation, Inc., Logan Telephone Cooperative, Inc., North Central Telephone Cooperative, South Central Rural Telephone Cooperative Corporation, Inc., and West Kentucky Rural Telephone." *Designation Order*, Appendix, n. 1 (emphasis added). That footnote reveals an inadvertent miscommunication: the Commission inferred that T-Mobile intended to redefine certain rural study areas. T-Mobile, however, did not intend to redefine the referenced rural study areas.

T-Mobile acknowledges that its Exhibit A did not explicitly identify the rural exchanges. Rather, the Exhibit included a list of wire centers. A list of wire centers is relevant because the Universal Service Administration Company (“USAC”), which administers the High Cost Program, requires ETCs to use wire center identification for reporting purposes.<sup>2</sup> However, as explained below, the Commission interpreted the wire center list as something less comprehensive than what was intended by T-Mobile, *i.e.*, designation in the entire rural telephone company study areas listed in Exhibit A.

As it happens however, there may be another reason that the Commission interpreted T-Mobile’s request as one requiring partial redefinition of some rural service areas. On careful review of current data, T-Mobile has discovered a few additional rural wire centers that are within its licensed service area and should have been included in Exhibit A. Accordingly, T-Mobile is providing a Revised Exhibit A to cure the miscommunication and the omissions.

- 1. Revised Exhibit A clarifies T-Mobile’s eligibility in Kentucky.**
  - a. T-Mobile’s Revised Exhibit A includes all wire centers for each rural telephone company service area it intends to serve in its entirety.**

In T-Mobile’s application, it provided an exhibit that identified, by Common Language Location Identifier (“CLLI”) code, wire centers that were relevant to its request for ETC designation. In retrospect, this exhibit would have been clearer if it had simply stated that T-Mobile intended to serve the entire rural carriers’ study areas and listed wire centers correlated to every exchange in the proposed ETC service area. Absent such a statement, it is possible to mistakenly infer that there can be only one exchange associated with each CLLI code. But that is not the case here.

<sup>2</sup> For example, competitive ETCs must identify ILEC wire centers when they file FCC Form 525 with USAC.

While there is often a one to one correspondence between wire centers and exchanges, some of the wire centers listed in T-Mobile's Petition serve multiple exchanges. For example, South Central Rural Telephone Cooperative Corporation, Inc. ("South Central") has fifteen wire centers in its entire service area. Exhibit A to T-Mobile's petition included each of the fifteen wire centers, by reference of their CLLI codes. The South Central wire center designated by CLLI code HRCVKYXA primarily serves the "Horse Cave" exchange but also serves the "Bonnieville" exchange. Because the Bonnieville exchange is not specifically referenced otherwise in the remaining fourteen wire centers, it appears that the *Designation Order* presumes that T-Mobile intended to exclude the Bonnieville exchange from its designated service area. In reality, T-Mobile serves the Bonnieville exchange and commits to serving it along with the other exchanges included in the South Central study area. T-Mobile requested that its defined service area include all exchanges served by South Central, and the Commission credited that request at page 6 of its *Designation Order*, stating "The Commission finds that T-Mobile should be certified as an ETC in the *requested service areas* served by rural and non-rural telephone companies, as listed in the Appendix to this Order." It appears that the Commission believed it was granting T-Mobile exactly the relief it had requested, but the Appendix to the Designation Order presumes a request somewhat narrower than intended by T-Mobile.

**b. Revised Exhibit A includes certain rural wire centers inadvertently excluded from the original petition.**

As noted above, T-Mobile's application included an exhibit that identified, by CLLI code, wire centers that were relevant to its request for ETC designation. Unfortunately, due to an inadvertent administrative error, some wire centers of rural telephone companies were excluded from Exhibit A, which may have added to the miscommunication of the scope of T-Mobile's requested designated service area. In the analysis performed prior to submitting its

application, T-Mobile sought to specifically identify those rural telephone company study areas that it would commit to serving in their entirety.<sup>3</sup> However, Exhibit A to T-Mobile's Petition inadvertently excluded certain of the wire centers T-Mobile serves in rural telephone company study areas. Consequently, while the Commission believed it was granting T-Mobile exactly the relief it had requested, the Appendix to the *Designation Order* presumes requested service area different than intended by T-Mobile. Revised Exhibit A addresses this issue by including the rural wire centers inadvertently excluded before, along with references to the corresponding rural exchanges. In addition, for consistency, the revised exhibit includes the names of all non-rural exchanges that correspond to the non-rural wire centers referenced in the *Designation Order*.

**2. The *Designation Order* should be amended *nunc pro tunc***

Since T-Mobile's Petition requested designation throughout the identified rural company study areas, mere identification of additional rural wire centers in those study areas does not enlarge the relief requested. Logically then, the Commission can clarify its *Designation Order* without affecting the designation date, which is July 14, 2010.

Timely clarification of the *Designation Order* will be simple, but important to the petitioner. T-Mobile requests that the Commission clarify that the "service area" in which T-Mobile is designated as an ETC includes (i) the wire centers of the non-rural telephone companies and (ii) study areas of the rural telephone companies identified on Revised Exhibit A, and that the effective date of the *Designation Order* remains July 14, 2010. This will make it unnecessary for the Commission to redefine any rural telephone company's service area. Clarification of the *Designation Order* in the manner requested will also eliminate the need for

<sup>3</sup> Conversely, the same analysis identified rural telephone company study areas that T-Mobile could not commit to serving in their entirety for various reasons, including that some of the wire centers are outside of T-Mobile's licensed service areas. T-Mobile did not intend to seek designation in study areas that would require the Commission to consider and/or approve any redefinition. For example, T-Mobile specifically excluded Mountain Rural Telephone Cooperative from its requested designated service area.

T-Mobile to seek concurrence with the Commission’s redefinition from the Federal Communications Commission (“FCC”).

The *Designation Order* also includes minor typographical errors that should be removed when the Commission addresses T-Mobile’s Petition for Clarification. These errors are shown in the table below:


WHEREFORE, T-Mobile respectfully requests that the Kentucky Public Service Commission clarify and correct its July 14, 2010 *Designation Order* and specifically:

- i. Designate T-Mobile as an eligible telecommunications carrier for purposes of receiving federal universal service support in the State of Kentucky effective July 14, 2010;
- ii. Designate each of the (i) rural telephone company study areas and (ii) non-rural telephone company wire centers on Revised Exhibit A as the T-Mobile service area for purposes of determining universal service obligations and support mechanisms, explaining that T-Mobile’s request will not require the redefinition of any rural telephone company service area;
- iii. Direct the Commission’s Executive Director to send the appropriate notice of the amended order designating T-Mobile as an ETC in the Commonwealth of Kentucky for the Revised Exhibit A ILEC areas to the FCC and the Universal Service Administrative Company;
- iv. Make the other corrections described in this motion; and
- v. Order such other relief as may be appropriate.
