O R D E R

On February 12, 2010, Fox Run Utilities, LLC ("Fox Run") submitted an application for authority to revise the utility's tariff and increase certain nonrecurring charges. The Commission Staff issued an information request for additional information on March 29, 2010. Responses to the information request were to be filed by April 12, 2010. On April 15, 2010, Fox Run filed a motion requesting a 15-day extension of time until April 27, 2010 to reply to Commission Staff's information request. Fox Run was notified, on April 15, 2010, that the 15-day extension was granted. On April 29, 2010, Fox Run, citing delays in obtaining information from third parties, requested a second 15-day extension of time to reply to Commission Staff's information request. Fox Run was notified, on May 6, 2010, that the second 15-day extension was granted.

On May 11, 2010, an informal conference was held at the Commission's offices in Frankfort. Counsel for Fox Run requested clarification of some of the items in the information request. He further explained that the utility had requested and not received quotes from other contractors as requested in the data request. On May 13, 2010, Fox Run filed incomplete responses to Commission Staff's information request, stating that

the remainder of the questions contained in the information request would be responded to when the documents were available. Fox Run's response to item 2 of the Staff's information request stated that the office administrator is paid \$15.00 an hour and this is the amount to be used for Clerical and Office expense labor rather than the \$20.00 per hour in the application.

On June 24, 2010, Fox Run filed information and revised tariff sheets in response to Commission Staff's information request. Commission Staff had requested Fox Run obtain additional bids for the disconnect and reconnect of a customer sewer line for nonpayment of the sewer bill. Fox Run was able to obtain one other bid, from Camden Environmental Service Co., Inc., which was significantly higher than the amount first proposed in Fox Run's initial filing.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Fox Run has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed charges.
2. The proposed charges are equal to the expenses incurred to provide the associated services.
3. The tariff sheets containing the utility's rates, rules and regulations filed in the case on June 24, 2010 should be approved.
4. The charges set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. Fox Run's proposed rates are approved.


2. The charges in the Appendix are approved for services rendered on and after the date of this Order.
