Informal Conference Memorandum

An informal conference ("IC") was held in this matter on Wednesday, April 21, 2010. A copy of the conference attendance list is attached. The purpose of the IC was to discuss: (1) the Motion to Consolidate Case Nos. 2010-00061 and 2010-00062; (2) potential additional time for parties to continue private negotiations on the Decision Point Lists; (3) potential submission of Negotiation Status Updates to the Commission; and, (4) a potential procedural schedule.

During the course of the IC, the parties stated that they agree additional time is needed for negotiations and prefer that a status update be submitted to the Commission. The parties agreed that negotiations, to date, had been productive and fruitful and additional time will likely help the parties resolve certain outstanding issues.

AT&T Kentucky recommended the submission of a status update within 30 days. Sprint recommended the submission of an update by June 4, 2010. Commission Staff asked the parties about the potential content for the written status update.

AT&T then suggested that the parties and Commission Staff hold another telephonic IC within 30 days for verbal updates instead of providing a written submission.

Commission Staff asked if the issue of the consolidation of the cases and the issue of one or two interconnection agreements submitted for Sprint CLEC/Sprint Wireless/AT&T Kentucky would be resolved during the continued negotiations. The

parties anticipate those issues will be addressed, but will update the Commission at the next IC on whether they have been resolved.

Commission Staff and the parties agreed to hold the next IC on Thursday, May 20, 2010 at 3:00 p.m. Commission Staff stated that as the parties are continuing their discussions, there was no need to address the procedural schedule issue at this point, but instead reserve it for May 20th. Commission Staff stated that it would ask the Commission to issue an Order giving the parties some additional time for negotiations and formally setting the next IC for May 20th.

The informal conference then adjourned.
