On August 10, 2010, the Commission issued a procedural schedule in this matter. That schedule states that rebuttal testimony was due on September 16, 2010.

As grounds for the motion, the parties state that, due to the simultaneous arbitrations occurring between these parties before other state commissions, including the submission of testimony during the most recent five days, counsels' workload necessitated moving for an extension.

Having reviewed the motion, the Commission finds that good cause has been pled and the extension of time should be granted.


IT IS HEREBY ORDERED that:
