ORDER

On December 18, 1991, in Case No. 1991-00138, the Commission approved rates for Natural Energy Utility Corporation (“Natural Energy”) and provided for their further adjustment in accordance with Natural Energy’s Gas Cost Adjustment (“GCA”).¹

On March 2, 2010, Natural Energy filed its proposed GCA to be effective April 1, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Natural Energy’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Natural Energy’s notice sets out an Expected Gas Cost (“EGC”) of \$5.5403 per Mcf, which is a decrease of \$.0294 per Mcf from the previous EGC of \$5.5697 per Mcf.
3. Natural Energy’s notice sets out no current quarter or total supplier Refund Adjustment.

4. Natural Energy's notice sets out a current quarter Actual Adjustment ("AA") of \$.1349 per Mcf. In calculating its current quarter AA, Natural Energy used the GCA rate of \$4.5651 approved in Case No. 2009-00481² for rates effective January 1, 2010, instead of the EGC of \$5.5682 per Mcf approved in Case No. 2009-00380³ that was in effect for October, November, and December 2009, for its "EGC in Effect for Month." Correcting for this produces a current quarter AA of (\$.1996) per Mcf and a total AA of (\$1.0042) per Mcf, which is an increase of \$.0004 per Mcf from the previous total AA of (\$1.0046) per Mcf.

5. Natural Energy's GCA is \$4.5361 per Mcf, which is a decrease of \$.0290 per Mcf from the previous GCA of \$4.5651 per Mcf.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Natural Energy on and after April 1, 2010.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Natural Energy are denied.
2. The rates in the Appendix attached hereto and incorporated herein are approved for billing for service rendered on and after April 1, 2010.
3. Within 20 days of the date of this Order, Natural Energy shall file its revised tariff sheets with the Commission, setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.


