O R D E R

On December 29, 2009, in Case No. 2009-00202,<sup>1</sup> the Commission approved rates for Duke Energy Kentucky, Inc. ("Duke") and provided for their further adjustment in accordance with Duke's Gas Cost Adjustment ("GCA") clause.

On March 12, 2010, Duke filed its GCA to be effective April 1, 2010.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Duke's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Duke's Expected Gas Cost ("EGC") is \$6.012 per Mcf, which is a decrease of \$.979 per Mcf from its previous EGC of \$6.991 per Mcf.
3. Duke's notice sets out no current quarter Refund Adjustment ("RA"). Duke's total RA is (\$.001) per Mcf, which represents no change from its previous total RA.

4. Duke's notice sets out its approved current quarter Actual Adjustment ("AA") of \$.349 per Mcf. Duke's total AA is (\$.005) per Mcf, which represents no change from its previous total AA.

5. Duke's notice sets out its approved current quarter Balancing Adjustment ("BA") of \$.001 per Mcf. Duke's total BA of (\$.042) per Mcf represents no change from its previous total BA.

6. Duke's Gas Cost Recovery ("GCR") rate is \$5.964 per Mcf, which is a decrease of \$.979 per Mcf from its previous GCR of \$6.943 per Mcf.

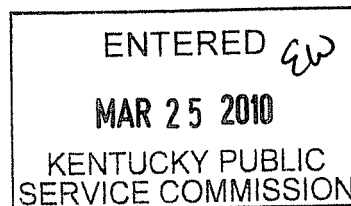
7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after April 1, 2010.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after April 1, 2010.

2. Within 20 days of the date of this Order, Duke shall file with this Commission its revised tariffs setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
