O R D E R

This matter arises upon the motions of ProLiance Energy, LLC (“ProLiance”) and Retail Energy Supply Association (“RESA”), filed May 28, 2010, for full intervention. It appears to the Commission that such interventions are likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission also recognizes that a procedural schedule was established in this proceeding by Order dated June 8, 2010. The Commission, being otherwise sufficiently advised, finds that ProLiance and RESA should be granted full rights of parties in this proceeding and should accept the procedural schedule as it now stands.

IT IS HEREBY ORDERED that:


1. The motions of ProLiance and RESA to intervene are granted, and ProLiance and RESA shall accept the existing procedural schedule.
2. ProLiance and RESA shall be entitled to the full rights of parties and shall be served with the Commission’s Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. Should ProLiance or RESA file documents of any kind with the Commission in the course of these proceedings, ProLiance and RESA shall also serve a copy of said documents on all other parties of record.
