ORDER

This matter arises upon the motions of Kentucky Industrial Utility Customers, Inc. 3. Should KIUC, Big Rivers, or LFUCG file documents of any kind with the Commission in the course of these proceedings, KIUC, Big Rivers, and LFUCG shall also serve a copy of said documents on all other parties of record.
