O R D E R

This matter arises upon the motion of the Kentucky School Boards Association (“KSBA”) for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission also recognizes that a procedural schedule was established in this proceeding by Order dated June 15, 2010. The Commission, being otherwise sufficiently advised, finds that KSBA should be granted full rights of a party in this proceeding and should accept the procedural schedule as it now stands.


IT IS HEREBY ORDERED that:

3. Should KSBA file documents of any kind with the Commission in the course of these proceedings, KSBA shall also serve a copy of said documents on all other parties of record.
