ORDER

On May 26, 2010, West Carroll Water District ("West Carroll") filed its Application for an increase in its general rates of \$93,975, an increase of 22.79 percent over adjusted test-period revenues of \$412,292. The proposed rates would increase the monthly bill of a customer using 5,000 gallons from \$38.40 to \$46.02, a \$7.62 increase.

Commission Staff performed a limited financial review of West Carroll's operations and prepared a Staff Report that was issued by Order dated July 28, 2010. In its report, Commission Staff recommended that the Commission approve the proposed rates. In our Order of July 28, 2010, we directed all parties to file their comments and requests for an informal conference or hearing within 14 days. We further stated that, if no comments or requests for informal conference or hearing were received in that period, this case would stand submitted for decision. The Commission has received no comments or requests.

The Commission, after considering the evidence of record and being otherwise sufficiently advised, finds that the proposed rates are fair, just and reasonable.

IT IS THEREFORE ORDERED that:

1. The findings contained in the Staff Report are adopted and incorporated by reference into this Order as if fully set out herein.

2. The rates proposed by West Carroll and set forth in the Appendix to this Order are approved for service rendered by West Carroll on and after the date of this Order.

3. Within 30 days of the date of this Order, West Carroll shall file revised tariff sheets with the Commission setting out the rates approved herein.
