O R D E R

The Order issued by the Commission on August 13, 2010 in the above-referenced matter is hereby amended.

Pursuant to 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED that:

1. A public hearing shall be held on October 12, 2010 at 10:00 a.m., Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky to examine the application of the Fuel Adjustment Clause of Kenergy Corp. ("Kenergy") from November 1, 2009 through April 30, 2010. If no interested party files written notice of its intent to attend this hearing with the Commission by October 8, 2010, this public hearing is canceled and the matter shall be considered submitted for decision based on the evidence in the record.

2. As the Commission's offices will be closed on September 3, 2010 in observance of a statewide furlough day and on September 6, 2010 in observance of the Labor Day holiday, Kenergy shall file with the Commission, by September 7, 2010, an affidavit attesting to its compliance or non-compliance with the requirements of 807 KAR 5:056.


3. Kenergy shall publish the following notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter sent to all customers. Kenergy shall file an Affidavit of Publication of Hearing Notice with the Commission no later than October 8, 2010.

A public hearing will be held on Tuesday, October 12, 2010, at 10:00 a.m., Eastern Daylight Time, at the offices of the Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Kenergy Corp. for the period November 1, 2009 through April 30, 2010. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than October 8, 2010. If no notices of intent to attend are received by that date, this hearing will be canceled, and the matter shall be considered submitted for decision based on the evidence in the record. Written notice of intent to attend this hearing should be sent to: Executive Director, Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602.

4. In all other respects, the Commission's Order of August 13, 2010 remains unchanged.
